Grusade for Traffic Safety in Chicago

is being conducted, beginning in August, by the Citizens Traffic Safety Board as a continuation of its educational efforts to reduce the terrific toll of 27,702 persons killed or injured in traffic accidents during 1951.

THE COST of all this death and destruction was approximately \$100,000,000...covering hospital bills, property damage, higher insurance premiums, lost time and lost business.

"THE CRUSADE is the most comprehensive educational effort ever made in a city the size of Chicago," Franklin D. Sturdy, director of the CTSB, says. "The five largest advertising agencies in Chicago volunteered their services in preparation of the material. It is an All-Chicago effort to remedy a problem that is Chicago's own—the problem of traffic accidents and traffic congestion."

SEVEN TRAFFIC RULES are offered by CTSB as the simple solution to Chicago's traffic safety problem:



DON'T WALK across streets between intersections except where a mid-block crossing is marked.



2. DON'T WALK across a guarded intersection except when authorized by a green light or policeman.



3. DON'T DRIVE faster than the speed limit



4 DON'T DRIVE when you've been drinking.



5. right of way at all intersections, except against a red light or a policeman's signal.



6. DON'T FORGET the MOTORIST must come to a full stop at every red signal and stop sign.



7. Don't park in streets that carry streetcars or buses nor on through streets between 4 and 7. A.M.
