Crew: 3 Switchmen & 1 Supervisor Report 0700 hours at Howard Terminal

Cars: 2, 5-50 series and 1 articulated unit Cars 5001, 49, 10

NOTE: While operating in the Kimball Subway, train speed must not exceed 25 mph.

- Arrive Leave
 - 0715 <u>Howard Terminal</u>. Run light to Skokie Shops with 2, 5-50 series cars to pick up articulated unit. Arrange consist so articulated unit is on the east end when leaving Skokie Shops.
 - 0815 <u>Hamlin Crossover</u>. Run light to Howard. Train is to remain on Skokie Branch until it can be berthed for loading on Track #2.
 - 0832 <u>Howard Terminal</u>. Pick up members of Charter group at north end of the southbound platform. Towerman will route train south onto Track #2, North-South Route. Follow Run #704 due to leave Howard Terminal at 0828.
- 0850 0851 <u>Clark Junction</u>. Towerman will route train south onto Track #1, Ravenswood Route.
- 0902 0903 Tower #18. Towerman will route train south on the Ravenswood Route.
 - 0910 Randolph/Wells. Pick up remaining members of Charter group.
- 0913 0914 <u>Tower #12</u>. Upon receiving the proper signal, motorman will proceed north onto the West-South Route. Follow Run #2 due by Tower #12 at 0910².
- 0917 0918 Tower #18. Towerman will route train west on the West-South Route.
 - 0924 <u>Paulina Junction</u>. Switchman will route train south onto the connector track.
 - 0937 <u>Harrison Junction</u>. Switchman will route train east onto northbound Track #2, West-Northwest Route. Follow Run #302 due by Harrison Junction at 0935².
- 0954 0959 Logan Square Station. Members of Charter group will alight for a 5-minute photo stop.

1230	1320 ²	54th Douglas Terminal. Members of Charter group will alight for a 50-minute lunch break. On orders and proper signals from yard foreman, motorman will route train in and out of terminal yard. Follow Run #108 due to leave 54th Douglas Terminal at 1319 ² .
1335	1340	18th Street Station. Members of Charter group will alight for a 5-minute photo stop.
1347	1355	Morgan Middle Track. Under the jurisdiction of the supervisor aboard the charter train, train will be routed in and out of Morgan Middle Track onto the westbound Track #D, follow Run #202 due by Morgan Middle Track at 1354.
	1356	Loomis Junction. Motorman will route train west onto the Congress Branch.
1401	1410	Kostner Station. (Not a passenger stop.) Members of Charter group will alight for a 9-minute photo stop.
1420	1455	Desplaines Terminal. Members of Charter group will alight for a 35-minute photo stop. On orders and proper signals from yard foreman, motorman will route train in and out of terminal yard. Follow Run #120 due to leave Desplaines Terminal at 1453.
1512	1515	Morgan Middle Track. Under the jurisdiction of the supervisor aboard the charter train, train will be routed in and out of Morgan Middle Track onto the westbound Track #D. Follow Run #124 due by Morgan Middle Track at 1512.
1516	1516 ²	Loomis Junction. Motorman will route train west onto the Douglas Branch.
1518	1521	Harrison Junction. Switchman will route train north onto the connector track.
