

Note:

- 1. Crew will consist of Motorman, Conductor and Switchman.
- 2. Crew will protect train by flagging at all appropriate times.
- 3. Options available to passengers after lunch:
 - 1. Remain on Special Train while on Old Logan Branch.
 - 2. Alight in Loop for lunch, then board southbound Douglas West-Northwest train at Lake or Monroe Streets leaving Lake Street at 12:58, 1:11, 1:23 or 1:36 PM. Board Chartered Train at Polk Street at 1:49 PM.
 - 3. Alight in Loop for lunch, then board southbound Congress West-Northwest Train at Lake or Monroe Streets leaving Lake Street 12:52, 1:05 or 1:17 PM and alighting at Medical Center, walking northeast on Ogden to Photograph Charter Train on Old Logan Branch, then walking south on Paulina to Polk where Charter Train may be boarded at 1:49 PM.

- 4. Agents at Howard, Jackson Park, Ashland (Englewood),
 Lake (Dearborn Subway), Monroe-Madison (Dearborn
 Subway), and 54th Avenue will admit passengers to
 paid area at appropriate times upon presentation of
 Tour Ticket.
- 5. C.E.R.A. will provide a Marshal for each car and at all locations where Photo Stops are planned, including those instances where any passengers will be separated from the Chartered Train for any time.
- 6. CTA Police to protect train during lunch break while train is standing on Old Logan Branch at Jackson Blvd.
- 7. Shops & Equipment Department will remove Bow Trolleys and Spring Bases, and also make doors trainable on Car 53 for Charter Trip. After Charter, Shops & Equipment will restore car to normal.
