

At the beginning and conclusion of the trip, the charter director, Eric Zabelny, and the charter train supervisor will check the train for damage and/or debris. Rail Supervisor, K972, will be in charge of train movements. Manager II, K-571, is the overall person in charge.

Employees may expect charter train participants to photograph CTA facilities and equipment.

Members of the charter train are to be afforded this privilege provided their actions are consistent with safe and efficient station and train operation.
