
Your 1991 - 1992 Student Riding Permit





You will be offered the privilege of purchasing a student permit, as long as you are enrolled and attending a Chicago Area Public, Parochial or other Private elementary or high school on a full-time basis.

The permit will be valid August 26, 1991 through June 19, 1992. The permits may be used Monday thru Friday 5:30am - 8:00pm.

You must present your permit face up at the time the fare is paid in order to ride for a reduced fare on a CTA bus or train. This privilege is subject to your following the rules shown below.

Conditions


- 1. Use of permit is limited to trips to and from regular day classes in a public, parochial, or private elementary or high school (including work/study programs) and or campus extracurricular activities, Monday thru Friday (when school is in session) between 5:30 a.m. and 8:00 p.m during period of validity shown on the face of the permit.
- 2. The CTA photo ID must be shown face up at the time the fare is paid in order to ride for a reduced fare on CTA vehicles.
- 3. The permit is to be used only by the student whose name and picture appears on the face of the card. A permit presented by a person other than the student will be confiscated.
- 4. This permit will not be valid on the following holidays: Labor Day, Thanksgiving, Christmas Day thru New Year's Day, Martin Luther King's Birthday, Good Friday and Memorial Day.
- 5. This permit must not be altered or mutilated in any way.

If any of the above conditions are violated, the ID will be **CONFISCATED.** There will be a \$5.00 charge for re-issuance of lost, stolen or confiscated cards. To replace lost, stolen or confiscated cards, call CTA, Special User Programs, 664-7200, 8:00 a.m. to 4:00 p.m.

Your failure to comply can lead to the loss of your riding privilege. Be wise. Protect this Privilege.

You will be offered the opportunity to purchase your permit, at your school, during the first few weeks of school.

If you choose to participate, you will need a personal color photo that will fit into the box shown below.



The fee for this permit is \$5.00 in cash, or money order made out to:

When you purchase the permit you may be required to do the actual assembly.

Be very sure you follow these instructions fully.


Use a ball point pen only

- 1. Mark the box M or F with an "x".
- 2. Print the school name.
- 3. Print your name.

- 4. Print your address.
- 5. Affix color photo on permit.

You will be given a sheet of mylar to seal your completed permit. Peel 1/2 of the mylar as follows:



If for some reason you do not purchase a permit while at your school, you must have an application, stamped with your school's address, your photo and \$5.00 in cash or money order and come in to the
